Road Work in the Township

The Board will be discussing projects for the remainder of the 2017-2018 fiscal year and looking at the 2018-2019 fiscal year for road projects. Ditching, graveling and brush removal has been done on some areas of the Township roads along with resurfacing another section of Oregon Rd.

Burn Permit and Emergency Information

***Burn Permits** - Residents living in the **Lapeer City Fire Department Area** may obtain a permit at the Lapeer City Fire Department website (www.lapeerburnpermit.com) 7 days a week. Located in the left margin of the page, residents will find a "Township Burn Permit Program" button. You may also get a permit by calling the Lapeer City Fire Department Mon - Fri from 8:00 to 4:00 at 664-0833. The fire department's office closes on all Federal holidays, as well as the Friday before Lapeer Days. Residents living in the **Marathon Area Fire Authority District** may obtain a permit at the Marathon Township webpage (www.marathontwp.com) or the Marathon Township office during office hours. Any burning **without a burn permit** is an **unauthorized burn and may be subject to a penalty**. ***Penalties when ordinance is violated: \$250.00 for first violation, \$500.00 for the second and \$1000.00 for any violation there after.**

***Smart911.com**—Protect The Ones You Love by creating a free Safety Profile at Smart911.com, which allows you to provide Police, Fire and EMS with lifesaving information during a crisis when every second count.

***ICE Program - ICE stands for "in case of emergency"**. By creating an ICE entry in your cell phone "contacts", if there is an emergency, the police or EMS can immediately reach your family. You can add more than one ICE contact. For example: ICE 2, ICE-Wife or ICE-Husband.

Important Township Information

***Tax and Assessing Information** - Tax and assessing information is available on our website. This information is free for your property. You will be required to create a log on and password, then you may view or print your information.

***Tax Receipts:** Will be mailed if requested.

***Credit Card Payments** - The Township accepts credit/debit card online or in the office for property taxes. There is a 3% convenience fee.

***Property Inspections** - To request a property inspection while your are away from home or to speak with a deputy, contact Central Dispatch at **667-0292** anytime

***Storm Assistance**— Please call Central Dispatch at 667-0292 to report needs ie: warming shelters, food and water.

***Hall Rentals** - Rental of the Township Hall is \$200 + \$100 refundable deposit and is available to Township residents only.

***Lions Club Glasses and Hearing Aid Box**—is located in the lobby at the Township Hall, if you would like to donate used items.

***White Drop Box** - Located in front of the Township Hall for dropping off items after hours.

***Recycling** - Recycling is held at North Lapeer Recycling in Deerfield Township, please call 793-7557 for time and cost. You can check with your disposal company for curbside recycling costs. Rick Rhein Disposal offers curbside recycling to his customers at an additional cost. Habitat for Humanity has recycling on the 1st & 3rd Saturdays of the month at a cost of \$4.00 per car.

***Building Permits** - a zoning permit must be obtained at the Township office before obtaining a building permit at Construction Code Authority.
